All students and others within the school have a right to be treated with dignity and courtesy. Conduct injurious to the mental and physical well-being of others is not conducive to good school morale within a safe environment. We must be guided by "Respect" in all actions and words.

Planned Absences

If you know you are going to be away from school because of family plans and other education related activities, have your parents call the school or send a note. It is the responsibility of the student to see their teachers for any work missed. Students must complete all missed work immediately upon their return. Failure to do so will result in the student not receiving their credits for the subjects in question. Every child is urged to form excellent habits regarding attendance & promptness. This is a required skill in the outside world. A good start to the day fosters a positive attitude.

Possession of electronic device that hinders learning

Immediately confiscate the electronic device Call or memo sent to parent in which case the parent must see the principal to retrieve the electronic device. Teachers will let the students know if an electronic device (ie. Laptop) is required for class.

Vehicles driven by students

Meeting with Principal

A letter will be forwarded to the student/parent reminding him/her of the safety of everyone in our school environment.

It is against the law to drive without a license. Should the student continue, then a report will be forwarded to the Police department.

Parental/Guardian Responsibilities

As a parent/guardian you should:

- Attend all reporting and information sessions for your child (ren) for positive feedback.
- Attend all requested meetings by Principal and or teacher
- Each year give your child's school your current telephone number, home address, work telephone number and emergency contact number. Understand and support the rules in this Code of Student Conduct and talk to your child about them.
- Make sure your child arrives at school on time every day.
- Leave your child at school no earlier than 7:55 am and no later than 3:30 pm (unless child is attending an authorized after school activity)
- Contact the school within 24 hours after your child is absent to tell them the reason for that absence.
- Tell the school principal if you move.
- Work with school staff members to solve any discipline issues or problems
- Be aware that when parents are divorced or separated, both parents have full rights to participate in the child's school activities and know what is happening at school unless there is a court document limiting that access. If such a paper exists then the principal must have a certified copy. A non-residential parent has access to student records and information unless a court order prohibits such access.
- Be prepared to pay for any damage done to the School property by your child.
- SIGN IN UPON ARRIVAL & DEPARTURE AT THE FRONT DESK & carry a visitor tag when you come to school before you go anywhere on campus.
- Adhere to school developed, on-site traffic plans for vehicles when bringing students to school or picking them up after school. Possibly a designated area will be in place in the future.

Parents must come into the school to pick up the student.

Respect for Self & Others

- Parents/Guardians who have a complaint about an incident involving their son/daughter or an unsatisfactory relationship between a teacher and their son/daughter, MUST follow this course of action.
 - 1) Talk to the teacher;
 - 2) Failing resolution at the teacher level, speak to the Principal
 - 3) If still unsatisfied, contact the Director of Education
- Parent(s)/Guardian(s) are asked to come in by appointment, to discuss their concerns in an appropriate manner. We prohibit the use of abusive/foul language and/or abusive misconduct.

If this occurs, the parent(s)/guardian(s) will be asked to immediately leave the school and/or school grounds. The local police department may be contacted.

An appointment can be set up later, when parent(s)/guardian(s) are ready to meet with the principal in an appropriate manner to discuss their concerns.

Depending on the severity of the situation and in order to ensure the safety of students and staff, the Kitigan Zibi Police may be asked to provide support in certain situations.

Glossary of Terms

Assault (including Verbal Assault)

A person commits an assault when:

- Without the consent of another person (s)he applies force intentionally to that other person, directly or indirectly.
- (S)he attempts or threatens, by an act or gesture, to apply force to another person, if (s)he has or causes that other person to believe on reasonable grounds that (s)he has, present ability to effect his/her purpose.

This applies to all forms of assault, including sexual assault, assault with a weapon, threats to a third party or causing bodily harm or aggravated sexual assault.

Detention

Detentions shall be imposed on students where it is believed that a student has acted in a manner which is detrimental to the good functioning of the school and where a student has demonstrated a lack of respect towards a fellow student, staff member, or anyone else within the school.

After 2 detentions for any reasons of misconduct, students will forfeit (lose) their \$10.00 school allowance for one month. Additional detentions will result in additional loss of future monthly allowances.

All students who are subject to lose their student allowance will be informed in writing by the Principal.

Expulsion

The permanent removal of a student from the school for exhibiting behaviors that is detrimental to the safety, welfare, and morals of students or of school personnel in the school.

Suspension

The temporary removal of a student from a classroom or school grounds for refusing to abide by the rules and regulations by which the school is administered. Suspensions can be either in-school or out of school depending on the severity of the incident.

Electronic Devices

Any apparatus that is detrimental to the learning environment used for purposes of communication or entertainment such as-but not limited to the following:

Mp3 player, cellular phone, camera, pager, beeper, ipod, portable DVD players, gaming devices, CD players etc.

Habitual Truant

A student who is absent from school for more than three times without a legitimate excuse.

Weapon

Any object that can cause serious injury to a person when used in an unlawful manner.
