Dear Band Members,

Here is an Assembly of First Nations of Quebec Labrador information note regarding Bill 97 Forestry legislation proposed by the Quebec government.

This bill is rejected by most Quebec First Nations, and it requires changes to protect all Traditional Aboriginal Territories that may be subject to forest harvesting.

Our Council hopes to address the resource management on all our Traditional Territory, and we are in the process of advancing an Aboriginal Title case.

Comprehensive historical research is being done to prepare our defense for an important Court case that will address Land Title.

Elders are being interviewed to help build our legal arguments. We have hired several legal experts, historians and anthropologists to build the best legal argument for our Title case in Quebec and Ontario.

This Court process is a costly exercise that will address the rights of our People for all our Traditional Territory and hopefully allow our People their rightful place on Algonquin Traditional Territory.

Our Nation has never signed a treaty with any government in place and have never given up our Rights to our Traditional Lands.

The British Regime of the day in 1763 enacted the Royal Proclamation that laid out the process for taking of Native lands. That process was never applied to our Algonquin Nation.

This Aboriginal Legal Title case will take several years but we are well prepared to defend our Title case. We will keep you informed every step of the way.

Our objective is to secure our rightful place on Algonquin Lands and ensure our involvement in all development on our land for the social and economic benefit of our People today and for future generations to come.

Strategy

SUMMARY

This note provides an overview of the latest developments concerning Bill 97 – An Act mainly to modernize the forest regime (Bill 97), and presents the communication strategy developed by the Assembly of First Nations Quebec-Labrador (AFNQL).

Please also note that the documents related to Bill 97 are now available in the Chiefs SharePoint. The folder includes briefing notes, correspondence, and summaries of meetings with ministers.

FIRST NATIONS COMMUNICATION STRATEGY

In anticipation of the parliamentary session beginning on September 16, 2025, and the expected start of the clause-by-clause consideration of Bill 97 in parliamentary committee, the AFNQL and the Chiefs Committee on Forests are preparing various political and media actions to promote and strengthen their position with civil society and the government.

The actions will take various forms in order to occupy the public space, including:

- A series of explanatory videos featuring various First Nations stakeholders;
- Citizen mobilization (e.g., peaceful demonstrations, distribution of informational materials, dissemination of information on the AFNQL's social media channels, etc.);
- Actions at the National Assembly (e.g., involvement of opposition parties, petition, press conference, mobilization in front of the National Assembly, etc.);

CONTEXT

2024

Following the recommendations issued by the Office of the Chief Forester, the Quebec government embarked on a major reform of the forestry regime. To this end, the MRNF held regional round tables on the future of the forests between February 15 and April 12, 2024, to which First Nations were invited alongside other stakeholders. Several First Nations and First Nations organizations participated in good faith to this process and shared their concerns, issues, and solutions.

As part of this initiative, the AFNQL sent a document outlining <u>First Nations' key principles relating to the forest</u> to the Minister of Natural Resources and Forestry, Maïté Blanchette Vézina. These principles present the vision of the First Nations Chiefs for a forest regime that respects their rights and interests and implements their aspirations.

On November 29, 2024, the MRNF presented to First Nations their broad orientations of changes for the forest regime. However, the content presented did not incorporate the visions and aspirations of First Nations.

February-March 2025

This situation led to closer dialogue between First Nations and the MRNF. Two meetings were held between the Minister and several AFNQL Chiefs on January 28 and February 14, 2025. Following these meetings, the Minister committed (French only) in a letter to the AFNQL to "continue the dialogue through a High-level Concertation Table".

April-May 2025

To this end, on April 16, 2025, the AFNQL held a special virtual assembly to create an AFNQL Chiefs Committee on Forests. Originally, the AFNQL Chiefs Committee on Forests was composed of elected representatives from Kebaowek, Lac-Simon, Long Point, Manawan, Mashteuiatsh, and Pessamit. Since then, other elected officials have also participated in the committee meetings (e.g., Essipit and Uashat Mak Mani-Utenam).

However, on April 23, 2025, Minister Blanchette Vézina tabled Bill 97 at the National Assembly despite the fact that the AFNQL and the Chiefs had repeatedly requested that the tabling date be postponed in order to incorporate First Nations concerns upstream.

Among other things, Bill 97:

- Proposes a new forest regime in the form of forest zoning into three types of zones (priority forest development zones, conservation zones, and multi-purpose zones);
- Provides insufficient recognition of First Nations rights that does not meet the roles they wish to play in forest management and planning;
- Proposes the development of an Indigenous consultation policy and the necessity of taking rights into account, without any concrete implementation mechanisms (sections 3 and 8);
- Reduces the exercise of First Nations rights on their territories to "activities pursued by Indigenous people for domestic, ritual or social purposes" (section 17.5);





Despite these elements, the Chiefs Committee on Forests participated in two meetings of the High-Level Concertation Table with the Minister on May 1 and May 22, 2025.

June-July 2025

On June 3, 2025, the Chiefs Committee on Forests, accompanied by several AFNQL Chiefs, <u>testified</u> (French only) before the Committee on Planning and the Public Domain to request the withdrawal of Bill 97 and denounce the insufficient consultation of First Nations. <u>A notice</u>, prepared by the AFNQL in collaboration with the First Nations of Quebec and Labrador Sustainable Development Institute (FNQLSDI), was tabled.

On June 19, 2025, at the AFNQL assembly, several elected officials emphasized the importance of rejecting the current version of Bill 97 and of planning collective action.

A meeting between the Minister Blanchette Vézina and the Chief of the AFNQL then took place on July 2, 2025. The Minister proposed "landing paths" without necessarily offering clear answers regarding the three fundamental principles requested by the Chiefs, namely:

- 1. Respect for the rights of Indigenous communities, as recognized and affirmed by section 35 of the *Constitution Act, 1982*, and by the UNDRIP;
- 2. The establishment of genuine co-management of the forest;
- 3. The complete withdrawal of the Priority Forest Development Zone (PFDZ).

Because of her position, the Chiefs Committee on Forests sent <u>a letter</u> to the Minister on **July 11, 2025**, announcing the suspension of their participation in the High-Level Concertation Table until these three fundamental principles were addressed. On the same day, the Minister sent <u>a letter</u> stating that some of these conditions were constitutional in nature and therefore beyond her purview. She also attached a document listing "<u>proposed topics for discussion</u>."

On July 18, the Committee of Chiefs on Forests <u>announced</u> the final suspension of their participation in the High-Level Concertation Table until further notice. An <u>open letter</u> with the same message was published on July 22.

August-September 2025

Although the Chiefs Committee on Forests has suspended its participation in the High-Level Concertation Table, First Nations mobilization against Bill 97 continues through the communication strategy.

On August 7, 2025, Minister Lafrenière of the Secrétariat aux relations avec les Premières Nations et les Inuit (SRPNI) sent a letter to the Chief of the AFNQL addressing the issue of forest blockades, proposing the creation of a "joint committee of experts" to make recommendations to the High-Level Concertation Table, and stating his wish to discuss **the following six priorities** with the Chiefs:

- 1. First Nations participation in economic spinoffs from forestry (benefit sharing);
- 2. The joint development of an Indigenous consultation policy;
- 3. The creation of a collaborative mechanism for the delimitation of PFDZ;

- The development of agreements for the delegation of forest management to First Nations on certain territories (≠ co-management);
- 5. The modernization of Quebec's approach to taking into account the ancestral rights of First Nations (section 35 of the Constitution Act, 1982, and UNDRIP);
- **6.** The establishment of a permanent discussion forum to address Indigenous issues and implement the Sustainable Forest Development Act.

In parallel with these political initiatives, <u>forest blockades</u> (French only) were erected in various locations across the territory (particularly in Haute-Mauricie) by the MAMO Group, which brings together land guardians and hereditary Chiefs. In response to the growing tensions on the ground, the Chief of the AFNQL issued a call for calm <u>on August 18, 2025</u> (see the article – French only). The MAMO Group rejects Bill 97 because of its anticipated impact on the rights and ways of life of First Nations, on caribou, and on the sustainability of forests, and wishes to be included in the discussions with the Quebec government.

On <u>August 19, 2025</u> (French only), Minister Lafrenière and Minister Blanchette Vézina met with the Conseil de la Nation Atikamekw, the three Atikamekw First Nations, and the forestry industry. It was agreed to work on a joint pilot management project, in consultation with families, territorial Chiefs, and community members. Indigenous representatives also agreed to return to the High-Level Concertation Table.

On <u>August 20, 2025</u>, the AFNQL, Minister Blanchette Vézina, Minister Lafrenière, and Premier Legault's office met. The Quebec government showed openness to co-writing a new version of Bill 97 through a joint committee of government and First Nations lawyers. The Chiefs maintained that the three fundamental principles must be addressed by the government before moving forward with these legislative procedures. Minister Lafrenière committed to providing further information within 24 to 48 hours.


Minister Lafrenière's response was received by the AFNQL on <u>August 22, 2025</u>. The minister mentioned that the parties had agreed on August 20 to collaborate on the three fundamental principles and on the establishment of the joint co-drafting committee by September 15.

On September 1, 1989, Kitigan Zibi took a significant step toward self-determination with the transfer of control of community health care programs. This momentous occasion allowed our community to administer health services and this paved the way for our Health and Social Services sector to thrive and serve the community the way we do today.

Did you know? Kitigan Zibi is the first First Nation in Canada to have taken control of its healthcare in the community. This pioneering achievement has paved the way for many other First Nations communities to follow suit, empowering them to take charge of their own health and wellness.



Scavenger Hunt Report

The Land, Water and Animals Advisory Committee invited community members and other First Nations people to a Scavenger Hunt that was held on Saturday, August 23, 2025.

This activity brought family and friends together for a day of fun, riding and seeing our territory, experiencing cultural tasks and language through challenges.

Four (4) vehicles joined the scavenger hunt, 1 vehicle had 4 participants, another vehicle had 3, the 3rd vehicle had 2 and a vehicle was solo.

Each vehicle was given 5 minutes between each departure.

The start-line was at Cultural Center beginning at 7:45 am. We began by going over the rules for the scavenger hunt. The 1st task was to make 2 braided bracelets per vehicle before receiving their 1st clue that sent them to Roland Waterfalls. The Algonquin word collected was "braid-okagenigan".

At the 1st checkpoint at Roland Falls, the participants had to search for Gene, complete a simple task as taking a selfie with the falls behind them to receive next clue. This clue led them to 2nd checkpoint which was Sherry Chabot's cabin. Algonquin word from 1st checkpoint was "waterfalls-kìshkàbikedjiwan".

2nd checkpoint at Sherry's, the participants had to identify if they heard a bull moose or cow moose. Once identified correctly, they received their next clue. Algonquin words collected here were "bull moose-ayàbe, cow moose-anidjàni". The clue they received here brought the players to Jon Decontie's cabin. The clue here led them to the Birch Camp.

3rd checkpoint was at the Birch Camp. The players' task was to identify 9 woodland animals (moose, deer, wolf, partridge, eagle, beaver, otter, owl and bear) seen on trial by memory. The Algonquin words collected at this checkpoint were monz, wawashkeshi, mahingan, pine, kiniw, amik, nigig, ohomisi/kokokoho, makwa.

The Algonquin words collected at each checkpoint aided the teams with their time at the finish. Each point collected lessened their time by a set amount of minute/s.

The winners of the scavenger hunt are:

1st place-Cote vehicle with Frank, Joanne, Doods and Cezin, they received \$500.00 KZ gas cards

2nd place-Deschenes vehicle with Judy, Corey and Summer won \$250.00 KZ gas cards
